Documents Required : Reissue of Passport / Passport Seva

(1) A document evidencing a change of name of a person resident in Kenya— (a) which is in Form 1 in the Schedule; and (b) in respect of which the following requirements of these Regulations have been complied with, shall, upon being registered, be endorsed by the registrar with the words “Registered in accordance with the Registration of Documents (Change of Name) Regulations”.
