The load is safe (lifted, in the air, on the ground) General procedure of lifting operation: - Determine the weight (mass) of the load and the position of its centre of gravity CG - Decide the method of lifting and slinging the load (overload) - The load is balanced- CG - Load is not damaged by the LE and LE is not damaged by the load.
